NOTIFICATION

WHEREAS inspectors under the Labour Commissionerate cause inspection of factories, shops, establishments etc. being empowered under different Acts & Rules and it has been observed that non-synchronous manner and multiple inspections under various Acts and Rules might be burdensome on businesses and on the entrepreneur. And;

WHEREAS the Labour Department vide its Notification No: 435/LW/3A-01/14 dated 15th June, 2015 ordered that synchronized inspection can be carried out under 16 Acts & Rules being administered by this Department through the Labour Commissionerate.

Now, in pursuance of the recommendation made by the Department of Industrial Policy & Promotion, Government of India under the 'Ease of Doing Business' in West Bengal and in partial extension of the abovesaid notification, it is hereby ordered that inspections under various sections of the Factories Act, 1948 shall preferably be executed jointly in a synchronized manner with the inspections being carried out in pursuance of the abovesaid notification.

The Labour Department shall take necessary steps in due course to develop an electronic interface for synchronization of the inspection Schedules of the Labour Commissionerate and the Directorate of Factories. It is further ordered, till such a time that a digitized synchronization does not come into force; it shall be the responsibility of the Chief Inspector of Factories, West Bengal to liaison with the Labour Commissioner regarding synchronization of inspections as ordered above.

This will come into effect on the date of issuance of this Notification.
